Holiday Lighting of the Barn

A group of Saddle Ridgers spent most of the morning on Monday, December 3, decorating the barn for

the holidays. We've upgraded the lights this year to all LED - much brighter, more energy efficient, and best of all, much easier to install. Board Announcements

Roadside mowing - Several residents have asked about the schedule for mowing the roadsides. The roadsides were not mowed last year so some areas are seeing more woody growth. We usually mow in late Fall to have the least impact on wildflowers and pollinators. The mower is currently out of commission. We are awaiting cost information on repair parts from the manufacturer and will make a repair/replace decision when that information comes back. In the meantime, if you have any places along the roads that are a safety hazard, let us know and we'll get a crew of volunteers with chainsaws and clippers out there.

Barn area projects - We need to run power to the trash barn for lighting. We're also going to build a ramp up to the door of the trash barn to make it easier to load and unload. We're getting an estimate for pouring a concrete floor in the barn area to store the new chipper which is on order through the Firewise program.

Unwanted visitors: The Board approved the purchase of multiple security cameras to put up near the gate and in a few known poacher entry points. This is in response to a couple of incidents this Fall involving trespassers. On Sept 22 a pickup truck was parked backed in off Saddle Ridge Road. It was reported to Blount County Sheriff's Office (suspected it was ginseng poachers). On Sept 25, Margaret Saunders encountered two ginseng poachers walking up Elks Point. On Sept 27, two young men, intoxicated, pushed the SR gate open and drove into SR in the middle of the night. They crashed their car in a ditch and were arrested. It's not clear what they were doing in SR but most likely not related to the poachers observed in SR. The Board decided that due to these incidents it would be beneficial to have strategically located security cameras.

Legal Task Force - On the advice of our lawyer, we have filed for a declaratory judgment stating that SRPOA is the Developer of Saddle Ridge.

Trash barn: Trash and recycling is picked up on Monday morning. Afterwards it is cleaned by the Ormandys. Please do not deposit trash in the barn from 7 am - 3 pm on Mondays so the Ormandys will have time to clean it and the barn floor will dry before things start accumulating.

Treasurer's Report

Currently, our inflows and outflows are running at or near budget. Some members still have not paid their annual assessments. We send regular reminders for them to please pay the amount owed.

The Board provides financial updates via email to all members four times a year, including the annual report that is distributed at the Annual Meeting. These updates are designed to keep members better informed about the financial position of our Association. The new backpack blower and trimmers purchased with Firewise funds came in very handy. This equipment is available to all Saddle Ridge property owners. If you need help with clearing leaves and other debris from your house, let someone on the Board know. We have also ordered a community chipper.

Thank you to everyone who has reported their Firewise activities. So far this year Saddle Ridge property owners have reported 1083 hours of Firewise activities meaning our community has gone above and beyond the required commitment to remain Firewise certified.
