# **Environmental Stewardship in Saddle Ridge**

Thank you all for your support and giving me the opportunity to serve the community. As the new member of the SRPOA tasked with chairing the Environmental Committee, I have been thinking about the definition of "stewardship" which is: *The careful and responsible management of something entrusted to one's care*.

The Saddle Ridge community is that *something* and we have taken on that stewardship when we chose to live within its bounds. The unique nature of this location asks for a unique way to live, different from city or suburban or farm living. Since moving in, I've seen (and heard) everything from Woodpeckers (who have poked holes in my shutters) to Cottontails (who, yes, do love clover more than weeds) to, of course, Black Bears (who are indeed interested in smells ranging from the kitty litter I used to dry leftover paint to the barbecue grill I didn't get scrubbed completely clean one night).

So now, as summer is closing and Nature's attention is turning towards stocking up food reserves for winter, I find it a good time to remember what our "neighbors" are doing and act as the good stewards we should be.



According to <u>bearwise.org</u>, in September bears become very focused on looking for food as much as 20 hours a day and can gain two to three pounds per day. And though the bears in our milder climate don't

hibernate fully, they still are very driven to build body fat as much as possible before winter. (Fun fact: oak trees produce more nuts than all other nut trees combined. Bears get plenty to eat on their own and don't need us to supplement their diet.)

This means, for us as stewards of our environment, to always be on the lookout for roaming bears, even after dark, and drive cautiously in -and outside- our community gate. Cubs are weaned by now, wandering a little more freely from their mothers, and are more difficult to see coming across the road in the dark.

This is also the time of year to ensure that our homes and properties are not bear-welcoming. Bears are also out looking for dens for the winter and I don't think we want our dens to become their dens! They might find their perfect spot under your porch or deck or inside your shed or possibly the crawl space under your house. (Another Fun Fact: bears do not have collar bones so even adult bears can fit through seemingly small openings... like dog doors. Yikes!) Now is the time to evaluate your property like a bear would and close up any appealing locations.

Living in Saddle Ridge, we have a special opportunity to be up close to true, wild, glorious nature. Our stewardship is to live with it, not despite it, and to care for it and enjoy it. I've learned that wooden shutters mean Woodpecker holes and I can replace them with another material; that if I don't want bunnies in my yard, don't plant a clover buffet for them; and for goodness sakes, clean my grill after dinner!

## **A Reminder -- Fire Protection**

Subscribe to the Blount County Fire Protection District for fire protection. The current subscription cost is \$170/year (BCFD <u>https://www.blountfire.org/new-subscription.html</u>). The fire department will fight fires for all Saddle Ridge residents, but without a paid subscription, you will be billed \$3,000/hour. If you are in an accident, for example, on East Millers Cove Road and the BCFP is called, the trip is covered by the subscription.

We've seen a lot of news this summer about wildfires. Some of the coverage of the Maui fire reminded us of a house in Shagbark that did not burn when the Hatcher Mountain fire surrounded it in April 2022. Shagbark is about 11 miles from Saddle Ridge off of East Millers Cove headed towards Pigeon Forge.

The Maui house was spared because the owners had recently had a metal roof installed on the wooden structure and the landscape had been hardened–plants and other flammable materials were removed, and rocks were laid around the foundation to the house's dripline. The Shagbark homeowner had thinned the pine trees and other vegetation surrounding the house (see photo below). Tennessee Forestry credits this with saving the house when others just downhill were destroyed by the fire.

Now is a good time to review the fire risk for your property. Schedule a Firewise home inspection with Beth Rushing <u>beth.rushing@gmail.com</u> and her team of volunteers. The team inspects only the outside of your home using a Firewise checklist to guide the inspection. The checklist stays with you for your guidance on how to best harden your home and property against fire.
