

Firewise Report

Saddle Ridge has been designated a Firewise Community for a number of years. The resources we've received over the years have provided for things like signage, purchase of equipment, and payments to contractors to help with removal of brush. One element of our application is a summary of our community's Firewise activities. This includes such things as the hours and dollars spent on making our homes and community more fire-resistant (both individually and collectively, such as our community clean-up days. Please follow this link to record your household's work to make your home more fire-resistant.

Summer is a time when we're spending a lot more time outside. The University of Tennessee Extention office has produced a <u>great resource on landscaping guidelines for protecting homes from wildfire</u>. It includes strategies for creating zones of defensible space, as well as recommendations for plants that support your firewise approach.
